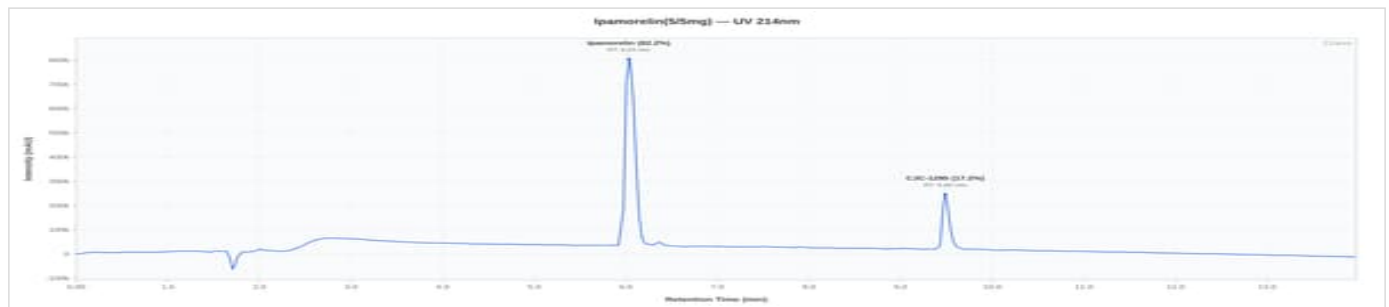

Notes & Methodology

1. Date Tested: 08/11/2026. Methods: Full QC Panel.
2. The sample was confirmed to be CJC/IPA by HPLC. Identification by chromatographic retention time comparison with a reference standard.
3. Elemental impurities analyzed by ICP-MS per USP <233> methodology. Acceptance criteria are internal laboratory quality screening limits for research-use materials and do not represent evaluation against any specific pharmacopeial monograph or product specification.
4. Endotoxin tested per USP <85> kinetic chromogenic method. Acceptance criteria per client specification.
5. Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
6. Per-component content determined by individual peak integration. Not all labeled components may be present.
7. Accreditation Scope: ILS Laboratories maintains ISO/IEC 17025 accreditation for activities listed in its published PJLA scope. Peptide testing reported on this certificate is performed for Research Use Only.
